# What is Sprint MultiLine?

Sprint MultiLine allows you to have two phone numbers on one mobile device. The second phone number is virtualized, so there's no need to swap SIM cards or buy a dual SIM phone.

With Sprint MultiLine, you add a companymanaged work number to your employees' personal devices, giving them a designated work number to place and receive business calls and texts, while keeping their primary number for personal use.

### **Business control**

Sprint MultiLine makes it easier to stay in control of company numbers, enforce the right policies and stay compliant.

#### One Keep business numbers

There are a lot of different costs to consider when thinking about enabling personal devices. But what about the cost of a lost customer?

When an employee leaves, they take their smartphone with them. But if they're one of the 60%<sup>3</sup> of people who use their personal mobile device for work, the customers calling them would now reach them at a competitor's office. That's no good.

With MultiLine, your pool of work numbers are corporate assets that you keep and control. So when an employee moves on, you can immediately re-assign their work number to someone else. This way, your customers reach the right person at the right company. Keep your business numbers, and your customers.

#### Two Stay compliant

If you're in a security-conscious business or a regulated industry, personal devices are a tough nut to crack. Regulations are important. Financial services firms need to record all trading-related communications. Healthcare and government organizations need strict internal policies to protect sensitive information.

Sprint MultiLine gives you a way to stay compliant with industry and corporate regulations, even for personal devices. For starters, it wasn't designed for consumers. So it meets the highest security standards with secure voice and text communications on the work line. Even better, you can deploy all the policies you need to, over the air. For instance, you might need secure voice recording and message logging to stay compliant with Dodd-Frank and similar regulations. With Sprint MultiLine, employees get to make business calls and send texts as usual, experiencing the same service quality, while you get an easy way to record only their business conversations.

# Simplify personal device management

### Three Accelerate device provisioning

A lot of businesses use carriers or third-party providers to provision (and deprovision) corporate devices and phone numbers.

The problem is, this can lead to long delays with costly consequences (like customers and business partners reaching an ex-employee at an 'old', not-yet-turned-off work number).

Sprint MultiLine puts you in control.

You get a pool of work numbers that you assign and re-assign as employees join and leave. And since it integrates with your EMM software, you can push or shut down work numbers over the air. It's quick. It's convenient. This kind of in-house number management is a big deal. It means you can be way more efficient and responsive as your BYOD program takes off and new mobile phones hit the market.

And it means employees who upgrade or replace a phone can start using their new device, with the same work number, in minutes.

#### Four Simplify carrier management

Negotiating carrier contracts can be difficult and time-consuming. And if you have relationships with multiple vendors, the procurement process is especially complex and labor-intensive.

### Five Drive down device costs

Productivity gains are the best reason to embrace employeeowned devices. But there's also a huge bottom-line benefit — you don't have to pay for new hardware.

J.P. Morgan Chase, for example, expects to save tens of millions of dollars by having more employees pay for their own mobile phones.<sup>4</sup>

The trade-off — until now — has been that BYOD was then harder to manage. But with MultiLine, you're just adding a work number to a mobile phone that the employee is responsible for purchasing, insuring, and replacing if it's broken or lost. And when Apple or Samsung release the next hot model, or retire an old favorite, you're no longer faced with a costly, large-scale upgrade to the corporate mobile fleet. Instead, employees decide which device will make them most productive.

### Six Lower mobile service costs


You'll also want to revamp your reimbursement policies and reduce your mobile service costs. With MultiLine, you may reduce the cost of mobilizing a workforce by 20% or more on a monthly per-user basis. The savings come from three areas:

Reimbursement: Increasingly, companies are being required to reimburse employees for usage on their personal service plans. So you need the right tools to track business-specific usage and optimize your reimbursement policies and costs. MultiLine's web-based reporting and integration with leading EMMs lets you specifically and automatically track and reimburse business usage on personal devices.

Monthly Subscription: With Sprint MultiLine, you're effectively just investing in new software. Aside from reducing the hardware costs we described in the last point, that also means you get the predictability of a per user, per month subscription service. It's easier to manage because it's broken down by user. And it costs less because it's software. Overhead: Your mobility program should lower the cost of supporting and maintaining mobile devices. With MultiLine, you avoid asset management and depreciation costs as well as the expense of provisioning, insuring, replacing and refreshing mobile devices.
